ORDER

1. The Mar Athanasios College for Advanced Studies, Thiruvalla, herein after referred as MBA College, have submitted the Prospectus before the Admission Supervisory Committee, in short the ASC, for approval and the same has been provisionally approved by the ASC on 20.03.2020.
2. The ASC through communication dated 02.11.2020 has directed the Principals of the MBA Colleges to submit the scanned copies of

the list and supporting documents of admitted MBA candidates for the academic year 2020-21 before the ASC for approval.

3. Accordingly, the MBA College through communication dated 07.12.2020 has submitted the list and supporting documents of admitted MBA candidates.
4. The MBA College has submitted the affiliation order received from the competent authorities for conducting the above course. The ASC scrutinised the affiliation order and found that the MBA College is having an intake strength of 120 MBA Seats in Self Financing Stream for the academic year 2020-21.
5. In the present Pandemic Situation, the ASC has relaxed the admission procedure and issued certain directives for admission to MBA Course 2020-21. Wherein the MBA College shall give first preference to those candidates who have qualified in any of the Entrance Test such as KMAT, CMAT & CAT. If any vacancy arises after admitting the qualified candidates, the 2nd preference will be given to the candidates who have secured positive score in any of the above entrance tests. If seats still remain vacant, the candidates shall be selected based on the qualifying degree examinations.
6. On verifying the records it is found that the MBA College have admitted 119 candidates in MBA Course for the academic year 2020-21. Among the 119 candidates admitted 79 candidates have qualified in Entrance Tests, 15 candidates based on Positive Score in entrance test and 25 candidates based on Degree Marks.

7. The MBA College further submitted a letter dated 03.02.2021 stating that candidate viz Gregory Biju has discontinued from the course. Hence the remaining admitted strength for the current academic year is 118.
8. The ASC scrutinised the documents of the 118 candidates admitted and found that the documents of 116 candidates are acceptable and they are eligible for admission to MBA Course. Therefore, the admissions of the 116 candidates are hereby approved, as per the list shown below.
9. Two (2) Candidates viz Geethi Dileep and Jacob Santosh Koshy have not produced the Degree Certificate and Consolidated Mark Sheet. Hence their requisite qualification cannot be evaluated. Therefore, the admissions of the above candidates are withheld subject to the production of Degree Certificate and Consolidated Mark Sheet.

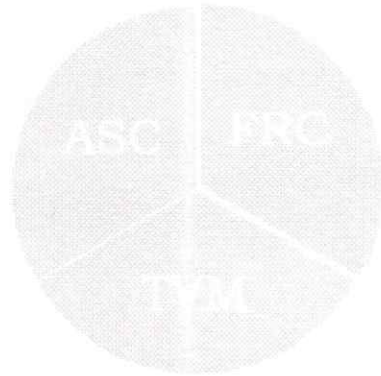

The Mar Athanasios College for Advanced Studies, in short the College, has submitted the Prospectus and admitted list of candidates for MBA Course, for the academic year 2016-17, for approval.

The Committee scrutinized the Prospectus and the fee structure. Both are provisionally approved, subject to the following Directives:-

The Photos of the faculty members should be included in the Prospectus as per the ASC Directives. The details of the Part time, Visiting and Guest faculties should also be included in the prospectus.

The sanctioned strength of the College as per AICTE for the MBA Course is **180** for the academic year 2016-17. The total admitted strength for the current academic year is **103**. Saji John, Clerk, Mar Athanasios College for Advanced Studies, has appeared before the ASC and submitted the list of admitted candidates with supporting documents.

Five (5) candidates namely **Akshaya Prakash, Arun Shibu, Parvathi S, Sandra Susan Koshy and Vijayalakshmi** were discontinued from the course as they are not qualified for MBA course. Thus the said candidates are **removed** from the admitted list. Remaining admitted strength, for the current academic year is **98**.

Accordingly the court directed to the college to consider the equivalency of B.com (Hons) degree obtained under the distance education stream of Delhi University and issue necessary equivalency certificate if permissible as per the procedure prescribed, which shall be done with a period of six months from the date of receipt of judgement. Hence the ASC decided to approve the admission of **Pooja Prakash**, subject to the decision taken by the University as per the Hon'ble High Court Judgement dated 03.11.2016.

Document of the **ninety eight (98)** candidates including **Pooja Prakash**, submitted by the College have been verified and found acceptable. Hence their admissions are **approved** as per the list shown below:-
